

Milburn Pennybags - \$MILBURN

1% Tax will go towards the **Monthly Jackpot** that will be given away every 1st day of the new month at night (UTC). The price will be 1% of the monthly trading volume up to a maximum of 75.000 USDT. In order to make a chance to win this this jackpot, one enters by simply holding an amount of \$MILBURN worth at least \$500,-



1% Tax will go towards the **Yearly Jackpot** that will be given in the first week of January (date and time TBA). The price will be 1% of the 1 year trading volume up to a maximum of 1.000.000 USDT. In order to make a chance to win this this jackpot, one enters by simply holding an amount of \$MILBURN worth at least \$1000,-

1% Tax will go towards **Marketing**.

The jackpots will be randomly chosen by an impartial bot, so it's all fair to all the contestants.

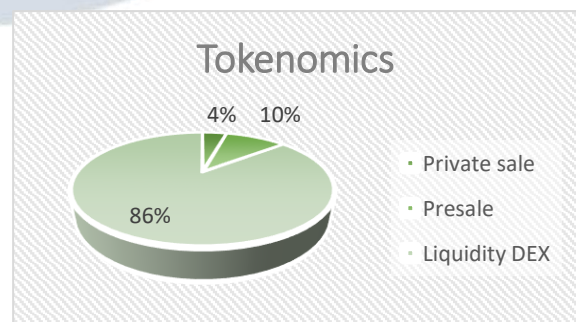
No need to say this project sells itself! But next to that, there are no team tokens. Liquidity pool will be locked for 6 months at first and will be extended as soon as the project really sets off.
